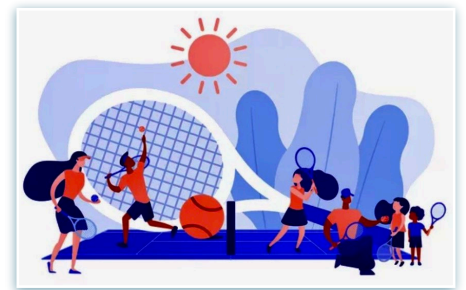


RULES AND REGULATIONS OF THE TOURNAMENT

2. Every Participant is guaranteed two (2) MATCHES. Main draw and consolation draw.
3. Arriving 15 minutes later than schedule will be disqualifying (USTA W.O. Rule #37).
4. Match warm-up will be 10 minutes. (USTA Rule #3).
5. Courtesy and good sportsmanship is expected. Tennis demand play by the rules with respect, cooperation, decency and proper behavior. LOST TEMPER, VILE LANGUAGE, RACKET THROWN/ABUSE, BALLS SLAMMED IN ANGER WILL BE DISQUALIFYING.
6. **Match Play Balls.** Return balls to the tournament desk after each match. Thank you!
7. If you're participating in the tournament, please keep your schedule open for the entire weekend. Due to the large number of matches, we won't be able to accommodate individual scheduling requests. First-round match times will be posted on **Thursday, May 14th**, so all players can plan accordingly.
